

HEF: An OCF Partner

The Hermiston Education Foundation is a proud partner with the Oregon Community Foundation. HEF's permanent endowment fund is managed by OCF to provide the Foundation with a steady income stream to offset operations, fund new and innovative programs and support other mission-critical activities. OCF's investment program combines the assets of permanent charitable funds for investment. meaning each fund benefits from the strength of a large, pooled portfolio. The result is high quality, diversified investment management at a reasonable cost.

As one of the largest community foundations in the nation, Oregon Community Foundation offers stability, expertise, and a proven commitment to donors and to Oregon's communities.

HEF's mission is to empower students to explore all academic areas as well as the arts. It is committed to providing students with the tools and knowledge necessary to build new ideas and excitement for learning.

Deferred and Life Income Gifts

OCF can work with donors and their professional advisors to establish bequests, charitable gift annuities, and charitable remainder trusts. Donors may choose to name HEF's endowment or their own OCF fund in their estate plan or enjoy an income stream for life, or a certain term of years, while receiving an income or estate tax benefit through a trust or annuity. Because deferred gift planning can be complex and there are variations within each gift type, HEF recommends, and can arrange, for you to plan your gift in consultation with your financial and legal advisors and OCF.

Bequests and Beneficiary Designations

Through your will or living trust, you can create your own fund or make a gift to support the HEF endowment with either a set dollar amount or a percentage of the residual. You can designate HEF's Endowment or another OCF fund as a charitable beneficiary of your retirement plan assets or life insurance policies.

Charitable Gift Annuities

In exchange for your donation of cash or securities, a charitable gift annuity pays you or another annuitant a fixed annual amount for life. After the death of the annuitant, the remaining assets can be used to support the HEF endowment or create or add to your existing OCF fund. The minimum contribution is \$25,000 and the donor must be at least 60 years of age.

Charitable Remainder Trusts

You can make an irrevocable transfer of an asset such as real estate or securities to create a charitable trust. The trust provides a

specified distribution percentage to one or more beneficiaries, for either their lifetimes or a term of years. After the trust ends, the remainder can be used to support HEF's endowment or create or add to your existing OCF Fund. The minimum gift amount is \$100,000 and the donor must be at least 55 years of age.
